

## **Chinook Winds Casino Resort Privacy Policy**

### **General**

Chinook Winds Casino Resort ("CWCR", "us" or "we") respects the privacy of all visitors to our Web site. We maintain this site to market and promote the many services and amenities offered by CWCR. In order to assist us in better serving our customers, we may collect certain anonymous information automatically, and may require certain personal information, including financial information, if you are making reservations or purchases or requesting information from us through this Web site. This Privacy Statement outlines the type of information that CWCR may collect and the manner in which such information will be used. All efforts have been made to ensure the accuracy of the information provided herein, however CWCR makes no warranties or representations as to the accuracy of the information supplied herein.

CWCR is a wholly-owned instrumentality of The Confederated Tribes of Siletz Indians.

### **Anonymous Information Automatically Collected**

We may collect and use certain information about your use of this Web site that does not personally identify you. This information includes your IP address and other information gathered through the use of "cookies". Cookies enable us to gather anonymous click-stream information, such as pages viewed, the date and time the site was entered, the type of internet browser you are using, the type of computer you are using, and the domain name of the Web site from which you linked to our site. This anonymous information does not personally identify you, and is gathered to help us develop generalized customer profiles to better serve our customers.

If you do not want information collected through the use of cookies, most browsers allow users to accept or reject cookies. If you set your browser not to accept cookies, you may not be able to take advantage of certain services that we offer on our Web site.

### **Personal Information Collected**

You may be required to supply personal information such as your name, address, telephone number and/or email address in order to receive certain information, participate in promotions, make reservations or place orders. A personal identification number provided by CWCR may be required to access certain personal information. By providing personal information, you agree to be placed on marketing lists and may receive promotional materials from CWCR from time to time.

Your personal information is stored on secure servers that are not accessible by third parties. We provide you with the capability to transmit your personal information via secured and encrypted channels if you use a similarly equipped Web browser. Personally identifiable information is stored on our Web server and is not publicly accessible. Further, personally identifiable information is only accessed by CWCR employees on a "need to know" basis. In order to ensure that all of your personal information is correct and up to date, you will be able to update your personal information. While we strive to protect your personal information, CWCR cannot ensure or warrant the security of any information you transmit to us, and you do so at your own risk.

**Age Policy**

Chinook Winds Casino Resort has no intention of collecting any personal information (such as name, address, telephone number or email address) from individuals under 21 years of age. Any offers, promotions or contests we conduct are not open to persons younger than 21 years of age with the exception of Poker players who are eligible to play at 18 years of age and older. We reserve the right to verify age at any time for any reason and may reject a person who does not have valid age identification as requested by CWCR. If a child has provided us with personal information, a parent or guardian of that child should contact us at the email address or phone number listed at the bottom of this Privacy Statement to identify the information that must be removed.

**Sharing Information**

The personal information you provide may be shared with other businesses owned or managed by The Confederated Tribes of Siletz Indians, and associated with Chinook Winds Casino Resort. These entities include The Chinook Winds Hotel, Golf Course and Fitness Center. We will not share or divulge your personal information to any non-affiliated third parties by us, except that such disclosure may be necessary to: (a) comply with a court order or other legal process or other legal requirements of any governmental authorities, including but not limited to authorities which regulate gaming activities; or (b) protect and defend the rights or property of CWCR.

This Web site contains links to other Web sites. We are not responsible for the privacy practices or the content of such sites. We have no control over its use and you should exercise caution when deciding to disclose your personal information.
